# **Dissemination of Corporate Communications**

Pursuant to new Rule 2.07A<sup>1</sup> of the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the articles of association of Cathay Media and Education Group Inc. (the "Company"), the Company will disseminate the future corporate communications<sup>2</sup> of the Company (the "Corporate Communications") to its Shareholders<sup>3</sup> electronically and only send corporate communications in printed form to the Shareholders upon request.

In this connection, the following arrangements will come into effect on 1 March 2024.

## ARRANGEMENTS

1. Actionable Corporate Communications<sup>4</sup>

The Company, through its Hong Kong share registrar, Tricor Investor Services Limited (the "Hong Kong Share Registrar"), will send the Actionable Corporate Communications to Shareholders individually in electronic form by email (1981-ecom@hk.tricorglobal.com). If the Company does not possess the email address of a Shareholder or the email address provided is not functional<sup>5</sup>, the Company will send the Actionable Corporate Communications in printed form together with a request form for soliciting the Shareholder's functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.

2. Corporate Communications

The Company will make the Corporate Communications available on its website (<u>www.cathaymedia.com</u>) and the Stock Exchange's website (<u>www.hkexnews.hk</u>).

A notice of publication of the Website Version<sup>6</sup> of Corporate Communications, in both English and Chinese, will be sent by the Company to Shareholders by email or by post (only if the Company does not possess the functional email address of a Shareholder) on the publication date of the Corporate Communications.
